1. Update from Local Enterprise Office

The update on the Local Enterprise Plan 2017 was circulated by Fiona Deegan, Head of LEO While many of the actions are ongoing or in progress, actions completed include:

- ✓ Provision of First Stop Enterprise & Business support through Twice Yearly Mail Shots issued to 2,500 clients
- ✓ Promoted and Organised Enterprise Award Competitions
- ✓ Promoted enterprise opportunities among young farmers in conjunction with Kildalton College
- ✓ Delivered Pilot bursary scheme in conjunction with the Design & Crafts Council of Ireland to incubate start-up craft enterprises
- ✓ Developed Action Plan to improve the visitor experience in County Kilkenny
- ✓ Action Plan developed to promote greater links between the tourism and food sectors through tastekilkenny.ie. Actively promoting local produce. An additional €40,000 has been allocated to drive this project further
- ✓ Engaged with Development Unit Kilkenny Co. Co. to promote investment
- ✓ Revamped promotional material Promoting County Kilkenny

- ➢ 325 Business advisory sessions were held
- ➢ 8 e-zines issued to better inform Entrepreneurs on business issues

2. Update on Economic Actions of Local Economic & Community Plan (LECP)

A business promotional brochure "Kilkenny" developed by the Business Support Unit was circulated by Brid Hynes. There followed a presentation elaborating further on the contents which highlighted the attractiveness of Kilkenny as a place to do business -

- The Exceptional Location
- The buzzing entrepreneurial culture
- High Calibre Talent
- A cosmopolitan city with a rich medieval heritage
- Unparalleled Property Solutions

The website and other promotional fact sheets have been updated

Sample Videos of local businesses have been produced in order to promote Kilkenny across all sectors

3. Update Abbey Quarter

The appointment of a new Chief Executive Officer (Kevin McCormack) has provided greater momentum to the progression of the project.

- Design of Mayfair and Brew house are almost completed
- Design is now complete on the River side garden
- Urban design almost completed LOCI are preparing a Report and a Development Code
- The utility services are being prepared
- Strategies for Parking and Energy will be available by end of month for review by Council
- Construction on Mayfair and Brew house flagged to commence 2018

• Lisneys and the Branding Company will make a presentation to Council in the next week or so. Once signed off Lisneys will prepare a Brochure

The Project is nearing the stage for engaging with The Enterprise Ireland Regional Development fund and prospective clients such as WIT led Precision Agriculture Centre of Excellence (PACE), Craft Council of Ireland and others

4. Small Business Vacant Premises Incentive Scheme

Despite the slow start, there has been an increased uptake on this scheme as a result of a targeted and a concentrated promotional drive across all sectors.

Consultation with applicants prior to application has helped eliminate ineligible applications

5. Tourism Update

- The Analysis on business tourism potential undertaken by Kilkenny County Council, Failte Ireland, Kilkenny Leader Partnership, Kilkenny Tourism has been completed and an Action Plan agreed
- Action Plan to improve the visitor experience and business capability of outdoor activity providers has been agreed
- KLP is supporting the development of the Graiguenamanagh Outdoor Hub and its sustainable usage
- Phase 1 of #Taste Kilkenny was successful with recent food tourism initiative which will aid local producers, marketing, food tourism etc. Phase 2 is imminent
- Asset Mapping across the County to develop area based specific tourism strategies is now complete
- A phased action plan for Development of Medieval Mile is agreed. New Brochure in production with Designworks
- Strategic Plan for festivals as an economic driver agreed
- Strategic Plan for Developing walking, cycling and waterways trail published.
- KLP is supporting by way of funding and staff time for the redevelopment of key elements of Trail Kilkenny strategy

SERSF is a Department of Education and Skills initiative, focusing on fostering stronger links between enterprise education & training providers, underpinned by:

- South East Regional Action Plans for Jobs
- Action Plan for Education 2017

The Role of Regional Skills South East

- > To Profile the South East Labour Force
- Provide more robust labour market information and analysis of employer needs
- Provide a single contact point to help employers connect with the range of services and supports across the education and training system
- Develop a structure for employers to become more involved in promoting employment roles and opportunities for career progression in their sectors

Sectors being targeted by SERSF and the Key Sectoral Skills Needs in South East Region were outlined

Higher Education Awards graphs were shown and discussed

Apprenticeships and the absence thereof was discussed

New Apprenticeships - industry-led in conjunction with IoTs & ETBs

Conclusion:

There is a tremendous amount of education & training provision in the region.

Greater input from different industry sectors is required to ensure that existing provision is fully up to date.

Significant scope to increase the level of 'workforce development' to ensure companies remains and improves competitiveness.

Delivery methods will need to change / expand.

Industry sectors in conjunction with education & training providers need to increase efforts to promote career opportunities in the region as talent is mobile
