EAPN Ireland Poverty Briefing and proposals for a new Anti-poverty Strategy

In February EAPN Ireland published a [Poverty Briefing 2018 and proposals for a new Anti-poverty Strategy](#). The Briefing presents up to date information on the levels of poverty and the issues behind them. It highlights the issues that impact directly on people’s lives such as inadequate income, access to quality services and the lack of a decent job for those who can work. It calls for a commitment and action across Government to address poverty and its causes and as the Government begins its consultation on a new social inclusion plan it outlines proposals across a range of policy areas.



Consultation on the National Action Plan for Social Inclusion 2018-2021

The Department of Social Protection has begun a consultation on a new National Action Plan for Social Inclusion 2018-2021. Full information on the Consultation is available [here](#). Debate on the Future of Europe

As reported in the last NewsFlash, the Department of Foreign Affairs and Trade is carrying out a series of Citizens' Dialogues across the country on the Future of Europe. - National Dialogue , Dublin (Venue tbc) 9 May 2018 (Europe Day)

The Wheel is also holding a Citizens' Dialogue from 9:30am - 12:00pm on the 5th April in the Wood Quay Venue, Dublin. More information [here](#).

These Dialogues are an important opportunity to highlight how critical it is that the EU puts the values of equality and human rights, outlined in EU Treaties, at the centre and builds a Social Europe for all. **You can read EAPN Ireland's submission on the Future of Europe** [here](#). In it EAPN Ireland calls for a more sustainable future for Europe based on balanced social, environmental and economic goals. This is what the EU, and its member countries including Ireland, has committed to under the UN Global Goals for Sustainable Development.

These Citizens' Dialogues on the Future of Europe are part of the consultation process initiated by the European Commission in March 2017. It published a White Paper which presented five possible options for a way forward for the EU. More information [here](#). In April 2017 the Commission published a [Reflection Paper on the Social Dimension of Europe](#) which concentrated on three of the five options for how the EU might address social and employment issues in the future.

Public Consultation for new National Action Plan for Social Inclusion 2018 - 2021

The National Action Plan for Social Inclusion 2007-2016 (NAPinclusion), identified a wide range of targeted actions and interventions to support the overall objective of achieving the National Social Target for Poverty Reduction (NSTPR). The Plan adopted a life-cycle approach with goals set for each group: children; people of working age; older people and communities. The Plan was updated for the period 2015 - 2017 to reflect the current issues and interventions to tackle poverty. There was a greater focus on modernising the social protection system, improving effectiveness and efficiency of social transfers and strengthening active inclusion policies. The Programme for Partnership Government includes a commitment to develop a new Integrated Framework for Social Inclusion, to tackle inequality and poverty.

The Department of Employment Affairs and Social Protection is in the early stages of developing the new National Action Plan/Integrated framework and would like to hear your views.

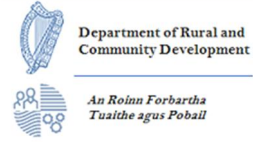
