Applications for funding towards developing Playgrounds

Who can apply

The scheme is open to all groups operating within the Community and Voluntary sector who have;

- I. An open and representative structure (legal basis),
- II. Operate on a 'not for profit' basis
- III. A policy of playground management and care of playground.

Level of grant aid available

Funding is on a competitive basis at a rate of 75% of the total eligible project. The total budget available for all projects funded under this targeted call is €50,000. While applications will be evaluated and potentially approved on their merits vis-à-vis the criteria to be published, it is envisaged the maximum level of grant aid for each application will not exceed €20,000.

Stage I involves completion of an **expression of interest** (EOI) form which can be downloaded from www.cklp.ie or can be provided by contacting the KLP main office on 056 7752111 or on email at eoic@cklp.ie.

EOI submissions judged eligible will be invited onto **Stage II** to complete an application form and have a Development Officer assigned to you to support you through the application process. **Note: eligibility does not confer an entitlement to grant aid approval. Projects that are approved for funding will be required to complete the appropriate public procurement process before decision to the final amount approved.**

The deadline for submission of Expression of Interest is **27th April 2018 at 17:00.**

Closing date for submission of Full Application is **28th September 2018 at 17:00** (excluding public procurement).

Iarratais ar chistiú i leith áiteanna súgartha a fhorbairt

Cé atá i dteideal iarratas a dhéanamh

Tá an scéim ar oscailt do ghrúpaí laistigh den earnáil pobail agus deonach a bhfuil na nithe seo a leanas acu:

- I. Struchtúr oscailte ionadaíoch (bonn dlíthiúil),
- II. Bonn neamhbrabúis
- III. Polasáí maidir le bainistíocht agus cúram áiteanna súgartha.

Leibhéal na cabhrach deontais atá ar fáil

Cuirtear cistiú is ionann agus 75% de chostas an tionscadail incháilithe ar fáil ar bhonn ionaíoch. Is é €50,000 an buiséad iomlán atá ar fáil do na tionscadail uile a mhaoineofar faoin nglao spriocdhírthe seo. Déanfar iarratais a mheas agus a cheadú ar bhonn a bhfiúntas i gcomparáid leis na critéir atá le foilsiú, ach meastar nach n-íocfar níos mó ná €20,000 de dheontas i gcás aon iarratais.

I gCéim I is gá foirm **léiriú spéise** (EOI) a íoslódáil ó www.cklp.ie nó a fháil ó phríomhoifig KLP ar 056 7752111 nó i ríomhphost ag eoic@cklp.ie. agus a líonadh isteach.

I gCéim II iarrfar ar aighneachtaí ar éirigh leo i **gCéim I** foirm iarratais a líonadh isteach agus ainmneofar Oifigeach Forbartha chun tacú leat le linn an phróisis iarratais. **Nóta: ní ionann cáiliú agus bheith i dteideal ceadú don chabhair dheontais. Iarrfar ar thionscadail a gceadófar cistiú dóibh dul faoin bpróiseas cuí soláthair phoiblí sula ndéanfar cinneadh faoi mhéid an deontais deiridh.**

Ní mór an léiriú spéise a fháil roimh a **5 tráthnóna an 27 Aibreán 2018.**

Ní mór an t-iarratas iomlán a bheith faighte ar a **5 tráthnóna an 28 Meán Fómhair 2018** (ach amháin an soláthar poiblí).
